2. Not to allow any development within 100m of any water courses in the Shire and that this is factored into the forth coming SoM 'watercourse hierarchy and protection strategy'. It should be noted that the SoM council voted against the SP79 in March 2021, for two key reasons:-
 - a. The inclusion of cul-de-sacs in the development design; and
 - b. the residential encroachment within 100m of Clutterbuck creek.
