PURPOSE

To recommend to Council the adoption of a priority ranking for the scheduling of capital work projects to improve/rebuild several Volunteer Bush Fire Brigade (VBFB) stations.

BACKGROUND

Six of the Shire of Mundaring VBFB stations have been assessed as requiring significant capital works from modification/renovation through to rebuilding to bring those facilities into a contemporary, fit for-purpose, Workplace Health and Safety legislation compliant state, with adequate space to garage and safely access current and future fire appliances.

Glen Forrest Volunteer Bush Fire Brigade, Captain, Glen Stenton representing the combined VBFB Captains has corresponded with the Shire stating a need to prioritise and plan for station upgrades to provide facilities that are fit for purpose for VBFB volunteers now and into the future.

The Emergency Services Levy (ESL) established in 2003, through the Local Government Grants Scheme (LGGS) provides grant funding (subject to application to, and assessment by, DFES) for facilities, appliances, training, equipment and the operational costs of VBFB's.

With the 2024/25 financial year, it is however noted that DFES has advised that its Capital Grants Committee allocated \$863,054 for 4 VBFB facilities from a pool of only \$1.44 Million available to Local Government Grant funding requests for the entire state of WA.

While establishing a priority ranking for the improvement or rebuilding of VBFB stations does not in itself bring about significant cost the combined capital works concerned could be estimated to be at a cost of five to ten million dollars.

• Western Australia has adopted national consistency for Cyclone, storm and flood, warnings join bushfire and heatwave in using AWS colours, icons and warning levels of Advice, Watch and Act and Emergency Warning. Warning levels can be upgraded and downgraded in the same way they are for bushfire to reflect the risk the community faces before, during and in the aftermath of a cyclone, flood and storm. The All Clear and Take Care warning levels will no longer be used under AWS and are replaced with an Advice Threat is reduced. This warning will advise the community that no further updates will be issued for that incident. Warning headlines are simplified, providing the hazard, warning level, action statement and location – giving impacted communities a clearer understanding of what they need to do.

All West Australians Reducing Emergencies Aware (AWARE) 2023-24 successful.

- Ref: AWARE2324-018, \$21,600 to cover training courses.
- Formal BAL Assessor training for six staff (6) to assist with community engagement in relation to personal preparedness, including retro-fitting older homes.
- Status course completed by all staff and promotion undertaken to raise community awareness (refer to Voluntary Fire Hazard Inspections for more details). Evaluation and acquittal underway.
